

KSHE 95 Battle of the Bands at Harrah's Voodoo Lounge

1. CONTEST INTRODUCTION: KSHE 95 will conduct the KSHE 95 Battle of the Bands promotion with Harrah's Voodoo Lounge. One band will be crowned champion and will receive the grand prize. Grand prize includes the chance to play a big KSHE concert next year at Verizon Wireless Amphitheater TBA in 2009, the chance to record a 3 song EP at Trailer Studios, \$1,000 for new gear, a feature on KSHE95.com, a live interview and performance on KSHE with Favazz, inclusion in concert program as KSHE Battle of the Bands Champion and tickets to the concert. 2. CONTEST DESCRIPTION: KSHE 95 will hold a contest for the chance for your band to be crowned the KSHE 95 Harrah's Voodoo Lounge Battle of the Bands Champion. Local bands will submit their own original music to Favazz at KSHE 95. We will pick 3 to 4 bands to play at the monthly battle at Harrah's Voodoo Lounge on the first Friday of the month. The winner from each month will be invited back to the finals where one band will be crowned the Champion. The first battle is Friday, January 2nd 2009. The final qualifying battle will be July 3rd, 2009. Finals will be held on a date TBD after July qualifying battle.

3. DESCRIPTION OF GRAND PRIZE: Grand prize total estimated retail value approximately \$9,000. Prize includes the chance to play a big KSHE concert next year at Verizon Wireless Amphitheater TBA in 2009, the chance to record a 3 song EP at Trailer Studios - ERV \$4,500, \$1,000 for new gear, a feature on KSHE95.com, a live interview and performance on KSHE with Favazz, inclusion in concert program as KSHE Battle of the Bands Champion and 100 tickets to the concert - approximate ERV \$3,000. Total ERV will be determined at time prize is awarded.

4. HOW TO ENTER AND WIN: Bands must submit their own original music on CD ONLY to Favazz at KSHE 95. Drop off or mail to KSHE 95 Battle of the Bands - Favazz, 800 St. Louis Union Station, St. Louis, MO 63103. Entries must be received one week before monthly battle. Deadline for all entries is June 19th, 2009 and schedule may fill up before deadline. Battles are first Friday of the month at Harrah's Voodoo Lounge on 1/2/09, 2/6/09, 3/6/09, 4/3/09, 5/1/09, 6/5/09, 7/3/09. Band must provide own instruments. Harrah's Voodoo Lounge will provide lights and sound. Limited to one entry per band. Band may attempt to enter monthly battle more than once if they don't win. Bands may only win one spot in the finals. Band may not attempt to win additional spot on another name. Sponsors are not responsible for printing or typographical errors in any entry related materials; stolen, lost, late, misdirected, damaged, undeliverable, incomplete illegible, or postage due mail or entries. Odds of qualifying for monthly band battle depend upon the number of eligible entries received. Odds of winning grand prize if you make it to the finals is 1 in 7.

Monthly Battle: If your band is chosen to be in a battle you will be notified at least one week prior to event. You will receive entry for the band members and one crew member. Band will also receive 10 tickets to give out as well as flyers to promote their event. Order of band performance will be decided by random selection prior to event. Band will perform 3 songs. Favazz will pick winner based on technical performance, stage presence, song quality and crowd reaction. Winning band will be invited to finals on date TBD in July.

Championship: The 7 winning bands will be invited to the championship on a date TBD in July. Bands will perform in order they qualified. Each Band will perform 3 songs. A panel of 3 KSHE judges will pick the champion base on technical performance, stage presence, song quality and crowd reaction.

5. QUALIFIER AND WINNER NOTIFICATION: All bands picked for a monthly battle will be contacted at least a week in advance of performance date. Band must be able to perform to enter contest. Winning band each month will be picked on site. Info on finals will be given to them at that time and updated as needed. All bands must perform in finals to be considered for Champion. Champion band will be notified on site at finals. KSHE 95, Emmis Communications, their parent, affiliated, subsidiary and successor companies, contest sponsors, other St. Louis area radio stations their affiliates, subsidiaries, distributors and advertising, promotional or judging agencies are not to be held liable if the winner cannot accept the prize due to illness, mechanical failure, inclement weather, Act of God, nor will the sponsors be held liable if the event is cancelled.
